### ${\mathcal P}$ OTTERY WALK

The old Red Wing pottery dump is a fascinating place for both locals and those visiting from out of town. For many years the dump has been explored and treasures are occasionally still found.

Earlier this year, the City of Red Wing, Port Authority and the Rotary Club came to the Red Wing Collectors Society Museum with an idea to establish a park near the Pottery Pond and original Red Wing Potteries site. This was a very exciting opportunity to preserve a key piece of Red Wing Pottery history. The area would be called Pottery Park and would have a trail with several interpretive and educational signs along the path. Since they have been approached, the Red Wing Collectors Society Museum has been working on a

plan to secure this historic place for

future generations. The pond and

area around these former pottery factory sites still have plenty of pottery pieces that speak to another time.

It is very much like an archaeological site with buried, half buried and exposed pottery. This area will help tell the story of past generations of potters and may fill in vital information in the timeline of pottery production.

The plan is to create a walkway with interpretive displays along the edge of the pottery dump. Red Wing city planner Brian Peterson says that there is both a tourism and economic benefit of a pottery walkway in the Pottery Park area and it holds great historic value. The City of Red Wing acknowledges the importance that the Red Wing Potteries played in the city's past and that it is still an important organization to the city today.

There are many details that will need to be decided and funding will be a major issue but the museum will be able to create the messages on the interpretive signs along the Pottery Park path.

The Red Wing Collectors Society Museum will ask the membership to get involved in preserving a critical piece of history for future generations. Ideas and funds will be needed to turn the Pottery Park into a reality.

Congratulations and thank you to all who contributed to making the 2004 July Convention a resounding success.

I announced, at the Annual Business meeting, that I had appointed two special committees for the purposes of implementing the recommendations from the Vision 2010 Report. The two committees and their charges are as follows:

Integrated Communication Plan
The Vision 2010 Report provided a
number of recommendations
regarding communication within
and outside of the RWCS for the
purposes of carrying out the
mission of the RWCS and in
growing and maintaining
the membership.

It is also believed that simply recruiting, retaining and expanding to a specific number is not enough and it is imperative to continue to offer a strong, valuable and viable product.

To carry out this mission, I have appointed the two Representatives at Large to co-chair a special committee for the purposes of:

1. Investigating the current methods to communicate within the membership, the Board of Directors, Chapters and external parties.

### INTERIM PRESIDENTS MESSAGE (continued)

- 2. Evaluating the number of people and the groups reached and the effectiveness of the current methods of communications used.
- 3. Determining ways to use those methods for recruiting, retaining and expanding membership and keeping a viable product.
- 4. Recommending changes, additions and enhancements including the cost/benefit ratio of implementing those recommendations that will result in an integrated communication plan for the RWCS.

The specific types of communication will include but not be limited to the Newsletter, Web Site, Minutes of BOD meetings, Traveling Display, Convention/MidWinter, Email and Video Conferencing.

### Alternate Revenue Sources

The RWCS is largely dependent on the July Convention and Commemorative sales, to generate enough revenue to operate throughout the year. This is becoming a more difficult task and additional sources of revenue or reallocation of revenue must be explored.

The Vision 2010 Report provided a number of recommendations with emphasis on implementation without increasing costs to the membership. The goal is to identify revenue to supplement one-half of the annual operating budget.

I have appointed Jerry Schleich, treasurer of the RWCS to chair a

special committee for the purposes of:

- 1. Evaluating the current revenue and expenditure history of the RWCS.
- 2. Exploring potential alternate revenue sources.
- 3. Providing recommendations regarding potential direction the RWCS could pursue to utilize alternate revenue sources in addition to the conventional revenue sources.
- 4. Identifying the benefit to one time only ventures versus longer-range opportunities.
- 5. Recommending the future need for such a committee on an ongoing basis.

Constellation of Each Committee

The committee will consist of representation from each Chapter and the membership at large and will utilize the skills of Board members and Business Office staff.

Timeline for Each Committee

The committee will meet for one year and will provide written recommendations to the Board of Directors at the spring 2005 meeting. The BOD will provide a report to the membership at the July 2005Annual Business Meeting and will publish the report in the Newsletter following the 2005 Convention.

Anyone who wishes to be a member of either committee should contact either chairperson.

You will find a survey enclosed in this issue of the Newsletter. It has been some time since the BOD has polled the membership to get input on future directions. Please take some time to complete and return this survey. The results will be tabulated and reported on in a future Newsletter.



## COMMEMORATIVE 2004



The 28th commemorative was revealed on Thursday, July 8th. There were more than 80 diehard Red Wing Collectors Society members lined up waiting for the doors to the commemorative room to open.

This year's piece is a miniature replica of a green brushed ware vase that was originally produced by the Red Wing Stoneware Co. in the 1920s and 30s. The original vase was created to be a 12 inch tall piece and was later offered in an 8- and 10-inch height. The commemorative is a little over 6 inches tall.


### TO BLEACH OR NOT TO BLEACH - STILL LOOKING FOR FEEDBACK

### Ray reiss keynote speaker




This year's Convention keynote speaker is well known to Red Wing Collectors Society members. Ray Reiss, noted author of "Red Wing Art Pottery including pottery made for RumRill" and "Red Wing Art Pottery Two."

Ray shared his story on how he started the first book and the often humorous and sometimes

challenging process to write the book. Reiss shared photos and live recordings of some conversations he had with influential Red Wing pottery designers and employees, including Belle Kogan, Charles Murphy and Rolland Everett. The book began to take shape at the 1993 RWCS Convention when Reiss talked to many people during that week to gauge the interest in doing an art pottery book and to see if anyone else was working on one. He soon learned that it was a bit unrealistic to write, photograph and publish a book in only 6 months so he altered his book schedule. The first book was really a 2½ year odyssey that had input from many knowledgeable people. "Due to the Red Wing Collectors Society and the generosity of the members, I would have never considered doing a book. People turned over their research, shared their expertise and allowed me to

photograph their pieces. I would not have been able to do it without all the support of many wonderful people," said Reiss. "The entire book process was very revealing and mind-boggling at the same time!"

Along with the two books, Reiss has also published the "Red Wing Dinnerware Price and Identification Guide." These three books have served as a comprehensive reference for many people over the years. They help both buyers and sellers in pricing and identifying pieces correctly. Reiss began collecting Red Wing art pottery when he lived in Baraboo, Wisconsin in the 1970s. He found plenty of art pottery at flea markets and it caught his attention so he began to collect it. Thus was the beginning of his love of art pottery and how he came to share it with others.




While talking with Ray Reiss after his keynote presentation, a gentleman came up to visit with Reiss. It was Bill Smith, who was actually in a photograph in Reiss' second book. Smith pointed out his photo on page 204 and talked to us about some of the items he designed for the Red Wing Potteries. An example of a piece Smith created, an ashtray, is on page 177 of the Reiss' "Red Wing Art Pottery Two".






Dinnerware. We hope to increase our attendance once again.








Meeting was called to order at 8:12 am. by Interim President Sue Jones-Tagliapietra. Special thanks was given to Sandy Short for her 12 years of service to the RWCS.

Changes to the agenda were as follows: Add the Historian Report, Financial Issues and 30th Anniversary Celebration discussion.

Motion by Jeff Floyd seconded by Steve Brown to defer items from the agenda until October. Motion carried.

Motion by Jeff Floyd seconded by Sandy Short to approve the minutes as amended of the May 1 & 2, 2004 Board minutes. Motion carried.

Auction Manager's Report given by Jeff Floyd. A total of 349 entries were received for the 2004 Auction. A total of 316 items were drawn in the lottery.

Education Manger Report given by Sandy Short. There are 21 presenters. The sessions will be videotaped.

Commemorative Manager's Report given by John Tremble. This year's commemorative ran behind schedule from start to finish and did not arrive for inspection and packing until June 3rd, a full month later than desired, but all went well. Sales for 2004 were behind budget by (-5%), 219 pieces were prepaid. Total pieces available for sale are 6,368; 452 more than budgeted. Overall quality were excellent and resulted in more being available for sale in the lottery. The average rejection factor was 11.2%, which is better than previous years.

Business Manager's Report given by Kay Wilshusen. Review of April, May & June financials.

Checks for interest money donations were given to the Interim President, for distribution at the Annual Business Meeting on Friday.

Craig & Elise Malmquist , Mike Foley & Ruth Neurhaugen were given passes to attend convention.

The St. James Hotel would like to know if the Society will need the Banquet Hall next year. In 2003 there were 142 banquet tickets sold. There were 82 sold for the 2004 banquet as of July 7, 2004.

Discussion on whether the RWCS have the Banquet at the St. James again next year. The Board decided to reserve the room at the St. James for 2005.

Historian Report given by Steve Brown. Steve reported on the displays at the Foundation Museum. Discussion on the deterioration of the kiln structure at the Pottery Place and that efforts to enclose that structure are underway.

Brochures are complete for the RWCS Foundation Museum and will be put in the commons areas of the Pottery Place, and also distribution of the brochures to the Board.

Moved by Steve Brown seconded by Jerry Schleich, that 50 legacy books be donated to the RWCS Foundation.

Motion carried.

The Foundation has a showcase that they would like the Chapters to use for displays. Steve will be discussing this during the Chapter Presidents meeting.

Representatives at Large report given by Jerry Erdmann & Wally Armstrong.
Jerry Erdmann - Michigan Chapter is up and running. Officers were elected.
Wally Armstrong gave his report on the Montana Chapter. Montana & North Dakota are trying to combine a chapter. Montana will be having a Chapter meeting in Room 210.

Idaho is trying to start a Chapter.

Chapter Reports:

Bruce Cameron & Mike Robinson reported that the California has 74 members. Maintain 4 meetings a year, and still having fun.

Jolene McKoon from the Illinois Chapter reported that they are working on 3nd commemorative. The fall meeting will be in East Dubuque.

Jerry Schleich from the Nebraska Chapter reported they currently have 62 members. Jerry Schleich reported the Southwest Redwingers had their Spring Fling and was well attended by the California Chapter. They also had a Road Rally that produced new members.

General Orders/Unfinished Business
John Tremble gave an update on the
Website. John & Todd Hintz will be
attending the Chapter Presidents
meeting for input on what could be put
on the Website.

Discussion on the Membership Survey that will be sent out in the August Newsletter. Discussion on putting Newsletter up for bid for summer 2005.

Moved by Steve Brown seconded by Jerry Erdmann that the current Newsletter contract terms and conditions be extended for a 1 year term, January 1, 2006 to December 31, 2006. Discussion. Motion defeated. One abstained.

Minor changes to the Annual Business Meeting agenda completed.

Charges to the 2 standing committees:

1. Integrated Communication Plan. Jerry Erdman & Wally Armstrong have been appointed the Chairpersons.

2. Alternate Revenue Sources.

Jerry Schleich has been appointed Chairperson.

The committees will consist of representation from the Chapters and the membership at large and will utilize the skills of Board Members, Business Office staff and Contracts as necessary.

Discussion on giving complimentary memberships. The Board discussed current policy on awarding complimentary memberships. No action was take at this time.

Discussion on distribution of the Membership List. The Board discussed the privacy issue of the Membership List. The Board decided to take a straw poll during the Annual Business Meeting. The Board will also review the results of the upcoming membership survey regarding the policy of keeping the membership list private.

Review of Rules & Regulations for Convention. All Board Managers need to have their policies on what their deadlines are for Convention for discussion at the October BOD meeting.

Financial Issues: Discussion on how Managers use their budget will be done in October.

A bill from Western Stoneware was received by the business office for the payment of the 2004 Commemorative. Included on the bill was a charge in excess of \$1,000 for 100 bowls that the Commemorative Manager is going to give to his volunteers.

Our current policy on the billing process is that any bills in excess of \$1,000 will have to be direct billed to the RWCS business office unless prior payment arrangements have been made with the Treasurer and/or approved by the Full Board.

Motion by Jerry Erdmann seconded by Sandy Short that the cost of the bowls be paid for by the Society.

Motion defeated. The Commemorative Manager advised he would pay for the cost of the bowls.

The 30th Anniversary of the RWCS will be 2007.

### Reminders:


