







### Rwcs hall of fame AWARDS PRESENTED

There are many members of the RWCS who have contributed to the growth and success of the Society. During the Convention, two Hall of Fame awards were presented at the annual business meeting July 11th, 2003.

Dave and Diane Hallstrom and Ron Linde were chosen to receive this special recognition of their lifetime achievements in regard to the RWCS. They are worthy ambassadors of the Red Wing Collectors Society. Here are a few of the contributions they have made over the years.

Dave and Diane Hallstrom- active RWCS members since 1981; RWCS Board of Directors-Convention Committee Co-Chairpersons from 1990 to 1997; RWCS 20th Anniversary Committee Chairperson Diane 1995 to 1997; Initial Mid-Winter GetTogether Organizers 1996; Display Room Contributors at multiple RWCS annual Conventions; RWCS

Foundation Officers from 2002 to the present; Charter Members of the Gopher Chapter, Dave a Past President.

Dave and Diane Hallstrom were the driving force behind saving the architectural start from the original North Star Stoneware Company building before demolition in 1993. The star is now the centerpiece of the North Star historical monument dedicated in 1996. Dave and Diane were also members of the committee that formed the RWCS Foundation in 2000 and were instrumental in bringing a permanent Red Wing Pottery Museum to the Pottery Place Mall. Their hard work and dedication has made these two important visions a reality.

Ron Linde, also recognized for making significant contributions to the RWCS, had these achievements noted. An active member since 1981; frequent RWCS Newsletter contributor and consultant,

Ron is a recognized authority in the history and development of the Art Pottery produced by Red Wing. His published original research regarding Art Pottery shape numbers has been a key advancement in cataloging the multitude of Red Wing Art Pottery Shapes. In the early 1990's, Ron performed and recorded interviews with Mr. and Mrs. Charles E. Murphy to capture their unique perspectives regarding the design of Red Wing wares. Through research, display, and speaking opportunities, Ron has shared his knowledge of Art Pottery.

## COMMEMORATIVE TAKES FLIGHT

The Red Wing Collectors Society 2003 Convention Commemorative is a reproduction of one of the figurine planters introduced in 1948. In selecting this year's piece, the goal was to cover one of the periods of time where we did not have a representative of the type of product produced in Red Wing among the previous commemoratives.

The planters in the series included the 1337 - Swan with Cygnet; 1338 - Deer; 1339 - Rabbit; 1340 leaping Pegasus; 1341 - standing Pegasus; 1342 - Dachshund; 1343 -Lamb; 1344 - Boy with flowers; 1345 - Girl with flowers and 1346 -Donkey. The 1340, Pegasus planter was chosen for the 2003 Commemorative due to the refined characteristics of piece and because it is a member of one of the first groups of new art pottery planters produced following World War II under the direction of Charles Murphy.

The Pegasus planters had a short production run which ended before the introduction of 1952 glaze colors. The other planters of the group enjoyed a longer production run and can be found in a wider assortment of glazes. The glaze colors that the Pegasus planters are commonly found in match the 1949 color chart of Matt White, Matt Green, Como Blue, Luster Grey, and Chartreuse. These planters can also be found with lining combinations of Matt White with green lining, Chartreuse with gray lining and Luster Grey with pink lining. Other combinations are listed in the 1949 color chart, but the Pegasus planters are not

commonly found in those colors. The 2003 Commemoratives were produced at Western Stoneware Company of Monmouth, Illinois. The production process started with the casting of a mold from an original planter, the production of a master die, refinement of the die, the addition of the raised wording and refinement of the master die to bring out the details in the face, mane, wings and tail of the planter. The planter is produced from a mold whose initial product is hand fettered to remove excess clay and smooth away the mold lines. The planter after drying is fired to a bisque finish, cleaned, sprayed with Como Blue glaze and then fired again.

The 2003 Special Commemorative is the same size as the regular commemorative except produced in Matt White. The design originally included spelling out RWCS into words, but the line where the mold separates did not allow clean detailing of the letters.

This year's total commemoratives distributed are less than 6,068, which matches the current membership. The original color selected was Matt Green. After being unable to consistantly match the green color, the decision was made to switch to Como Blue.

The Special Commemoratives are given to Convention attendees, early registers for Convention, a Newsletter submitter, two volunteers and Annual Board meeting attendees through a random drawing and awarded to winners of the Display competition. One is also sold at the Thursday night auction.

Congratulations to Karla Gartzke of Blue Earth, MN for being chosen to receive a special 2003 Commemorative for contributing to the Newsletter!





The long running American Pottery, Earthenware and China (APEC) Show and Sale has a new location this year. New promoters Jim and Ellen Tyne of DeKalb, Illinois, announce that the 26th annual APEC Show will be Sunday, October 18, 2003 at the Lake County Fairgrounds in Grayslake, Illinois. Show hours are 9 a.m. to 4 p.m. APEC has been held for the last 23 years in Springfield, Illinois in late September. The Tyne's inherited the show from Norm Haas of Michigan when he decided to retire. They are moving the show north, to a location midway between Chicago and Milwaukee, with the hopes of drawing a larger audience.

The show consists of approximately 50 dealers featuring both art pottery and dinnerware in both classic and moderns styles. Several new potters will also be selling their wares. APEC has a longstanding tradition of presenting great pottery and dinnerware in a friendly environment.

For entertainment and education, the Iowa Pottery Association will provide a pottery identification table. Each person attending the show may bring one mystery piece to (hopefully) be identified. Also appearing at this year's APEC will be the American Art Pottery Association Fakes Exhibit, consisting of many pieces of art pottery fakes and reproductions. Jim and Ellen Tyne are full-time collectors and part-time dealers who set up at shows throughout

the Midwest. Jim volunteers as show manager of the Wisconsin Pottery Association's annual Show and Sale in August. Ellen serves on the board of the Watt Collectors Association. They are excited to be providing another quality pottery show in the Midwest and look forward to seeing you there.

Moved and carried to continue with the narrated bus tour at Convention even though there is construction in the area.

Business Manager Report given by Kay Wilshusen. The April Financial Report was reviewed. An audit was completed by the state of Minnesota and changes are being pursued. The following has been completed for the trade names named in the Bylaws:

RED WING COLLECTORS SOCIETY

Auction Report by Jeff and Paulette Floyd: There were a total of 353 entries for the auction representing 28 more than last year. 311 were selected via lottery representing 10 more than last year.

Commemorative Report by John Tremble: 6300 commemoratives will be made this year. Special commemoratives: Moved and carried that the special commemorative distribution process this year will change from two distributed at the banquet to two distributed to attendees at the annual business meeting. In the event there are any extra special commemoratives from Display winners, those extras will be distributed at the banquet.

The Early Bird drawing was held and the winner identified to the commemorative.

Education Manager Report by Sandy Short: Two LCD projectors and two Carrousel Projectors will be purchased prior to July Convention. Moved and carried to approve spending \$350 from the web site budget to compress and upload the overall Convention video for use on the web site. It will be the master copy plus 5 copies. There will be a donor wall in the museum to acknowledge the various levels of donors.

The RWCS Foundation Board has developed their budget with the understanding that due to the lower interest rates, future donations received from RWCS will be smaller than in past years.

The Sewer Pipe Whistle is now on display in the museum.

Oral history project tapes and transcripts (482 pages) have been received and are being reviewed. It is an excellent academic history of the Red Wing Potteries.

Business Manager's Report given by Kay Wilshusen:

The June financial report was reviewed.

The total 2002 interest money donation was \$13, 032. 76. Per the voted on 90/10 percent split, the RWCS Foundation received \$11,729.48 and the Goodhue Historical Society received \$1303.28.

Moved and carried to continue the MidWinter GetTogether in Des Moines for 2005 and 2006.

Auction Manager Report by Jeff Floyd

A good selection was submitted and selected via lottery this year.

Commemorative Manager Report by Holly Tremble

Commemorative production was approximately 6400 pieces. Approximately 1000 will be available for the lottery. Expenses should be under budget. The postal service tier system for mail has varied the cost from \$3.95 to \$5.75 depending upon the recipients zip code. Moved and carried to authorize the commemorative managers to buy a postal meter and scale to expedite the mailing of commemoratives. The commemorative program continues to be primarily staffed by Gopher Chapter members as it has been for the past ten years.

Education report by Sandy Short:

The LCD projectors and Carousel projectors have been purchased.

Representative at Large Reports by Jerry Erdmann and Wally Armstrong:

Discussion will be had with two Chapters regarding continued status of some Chapters that have been inactive. Action will be taken at the fall board meeting.

#### Announcements

A moment of silence was held for departed members.

Motion by Mike Robinson and seconded by Gerald Strott to approve the minutes of the July 12, 2002 minutes were approved as mailed. Motion carried.

Treasurer's Report was given by Jerry Schleich. Mr. Schleich presented the Statement of Revenue and Expenditures for the year ended December 31, 2002. The total revenues were \$652,134.52 and expenditures were \$581,985.58 for net revenue of \$70,148.94. The treasurer's report is published in the Newsletter on an annual basis. Membership Report was given by Marcia Hislop, RWCS business office. The RWCS now has members in Canada and Belgium as well as Hawaii and Alaska.

Active members as of July 11, 2003 is 6,032 with 59 members joining in the first two days of Convention.

Manager's Reports:

Auction report was given by Jeff and Paulette Floyd

Another successful auction realized total sales of \$161,590 representing about \$29,000 more than the 2002 auction.



Commemorative report was given by John Tremble. The commemorative for 2003 is a 1948 produced Pegasus horse. Approximately 6400 commemoratives were produced.

Special Commemoratives were awarded to: Convention attendees Kathleen Novak and Carol Bonde as well as a special drawing among the volunteers of Catherine Beall and Dave Hallstrom and two business meeting attendees.

Education report was given by Sandy Short.

45 sessions with 21 presenters. There is always a need for presenters at summer Convention.

Kids View – 111 children registered for the Kids View seminars. The children developed a book about stoneware, had a very successful auction, painted plates, made stoneware jugs and had a number of other activities. Channel 11 from Minneapolis filmed on Friday and featured Kids View on the Friday, 5:00 p.m. news. RWCS members donated over 100 items for the kids auction which greatly contributed to the success of the event.

Our knowledge was greatly enhanced regarding the Sewer Pipe Industry due to the work of Mr. John Tremble.

There is a great project by Larry Roschen and Terry Moe to gain a better understanding of when each pattern of Red Wing dinnerware was introduced and subsequently discontinued.

The bus tour at Convention of the Oakwood cemetery gave members the opportunity to view some unusual Red Wing items.

#### OLD BUSINESS

Vision 2010 Final Committee Report was presented by Larry Roschen. The committee met mostly via e-mail. The report with recommendations was submitted to the board last fall.
