The Historic Preservation Committee of the RWCS is delighted to announce a joint oral history project with the Goodhue County Historical Society Museum! The purpose of the project will be to capture what's left of the history of the clay industry in Red Wing through audio- and/or videotape interviews that elicit intimate knowledge from former employees, employers, relatives, and friends. This long overdue project will develop an important record of information, before it's gone forever.

The following RWCS members serve on the Historic Preservation Committee (formerly known as the Acquisitions Committee): Jerry Flicek, Larry Roschen, Wally Armstrong, and Corrinne Reed from the Board of Directors; and Russa Robinson, Pete May, and Gary Tefft representing the general membership. Steve Brown, the Society's new historian, will also be working jointly with the committee and Goodhue. The overall coordinators of the project will be Gary Tefft for the RWCS, and Mary Maronde for Goodhue.

We urgently ask all members to help

us in this daunting undertaking by providing us with names/addresses/phone numbers/email of people to interview. With some former employees scattered as far away as New York and Israel, we realize the logistics of the project may be difficult at times, but, if nothing else, we can conduct telephone interviews.

If you are a former employee or employer who worked in any facet of the clay industry in Red Wing, including sewer pipe; if you are a relative, or friend of someone who did; or if you have knowledge of any of the aforementioned, please contact the coordinators of this project immediately. As revealed at the Convention, the 1998 RWCS commemorative is a miniature blue-glazed version of the *Iris* pitcher. The 1998 Convention logo (in blue ink) and "RWCS 1998" (in raised type) appear on the underside. The commemoratives were made by Western Stoneware of Monmouth, Illinois.

Final statistics are still being compiled at this writing, but over 6,400 prepaid orders were received. Of these prepaid orders, over 2,700 orders were to be mailed to members. Mailed commemoratives were scheduled to be picked up by the Postal Service Friday, July 17 and should have arrived at members' homes shortly thereafter.

However, over 300 members who ordered mailed commemoratives have memberships that expired 6/1/98 or earlier. [As stated in the rules, memberships must be current at the time of the Convention in order to receive a commemorative.] These members were sent a letter of explanation, and their commemoratives will be held until the Membership Committee confirms that dues have been paid.

We are very pleased with the feedback we've received so far about this year's commemorative. We were also very happy with our distribution system this year; most members were able to move through the lines with only a brief wait.

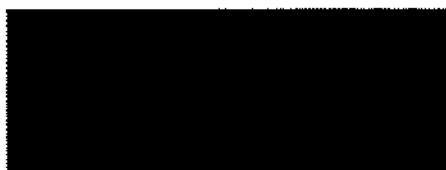

# MEETING MINUTES



President Olson called meeting to order at 9:05 am. Moved by John Key, seconded by Jerry Flicek to approve minutes of May 2 & 3, 1998. Motion carried.

Treasurer Jerry Flicek reported RWCS solvent.

Historian Corrinne Reed presented an inventory of RWCS archives. Moved by Larry Roschen, seconded by Ruby Benson to examine the cost of a \$25,000 insurance policy for the archives. Motion carried.

Chuck Richardson, president of the Goodhue County Historical Society, thanked the BOD for the years of support by RWCS and requested investigating forming a joint committee to maintain a history of RWCS.

Committee Reports: Auction, Commemorative, Display and Publicity all reported everything was ready for Convention. Education, Sandy Short still needs microphones for speakers. Moved by Sue Gillmer, seconded by John Key to allocate an additional \$500 for a total of \$1,000 to purchase microphones for seminar presenters. Motion carried.

MEMBERSHIP John Key stated not all nominated candidates are members is good standing. This has to be dealt with by the nominating committee. Moved by Rich Cronmeyer, seconded by Sandy Short that RWCS join the Red Wing Chamber of Commerce, the Visitors and Convention Bureau and the Red Wing Downtown Council. Motion carried.

Kay Wilhusen reported on Convention preregistration and office space for the RWCS.

East Rep Osterholz and West Rep Armstrong reported chapters were growing. Illinois is interested in developing a chapter. Interested members should contact Marv Osterholz.

NOMINATIONS Rich Cronmeyer

reported no other candidates have been nominated.

ACQUISITION Subcommittee Chair Corrinne Reed reported on changes going forward to the membership at the annual Business Meeting, renaming the committee and budget allocations. Moved by Wally Armstrong, seconded by Sue Gillmer to recommend to the RWCS membership to replenish the Acquisitions Subcommittee budget by \$3,750, for a \$7,000 total. Discussion. Motion carried.

Jerry Flicek reported that RWCS needs an indemnification article in its by-laws before errors and omissions insurance can be purchased.

Annual donations of earned interest money Moved by Rich Cronmeyer, seconded by Jerry Flicek to recommend to the membership at the annual Business Meeting to donate \$1,656 uncommitted funds, and \$5,000 designated for an oral history project of Red Wing potteries, to Goodhue County Historical Society (GCHS), if that is acceptable to GCHS. Motion Carried.

Wally Armstrong showed the revisions made on the RWCS webpage. He will continue to monitor and maintain the RWCS website. Moved by Jeff Benson, seconded by Ann Nelson to allocate \$1,000 to continue the website through the Fall BOD meeting. Motion Carried.

Adjourned at 12:10 pm.

Moved by Jill Holmes, seconded by

Jerry Schleich to approve the minutes of July, 1997 as published. Motion carried.

Jerry Flicek presented the treasurer's report. Moved by Mike Zaeske, seconded by Judy Schwartz to approve the treasurer's report. Motion carried.

Jeff Floyd reported auction gross sales of \$140,475.50. There were no "no shows" this year!

Larry Roschen reported that 8,000 commemoratives were produced. Over 6,400 were prepaid, of which 2,740 were mail outs. Approximately 700 non-prepaid were sold.

John Key reported that membership is steady at around 7,000 members.

East Representative Marv Osterholz, thanked everyone for their help and expressed an interest in developing an Illinois chapter. West Rep Wally Armstrong reported on nine chapters.

OLD BUSINESS Acquisitions chair Corrinne Reed requested two revisions to the charter. Moved by Corrinne Reed, seconded by Con Short to change the language of the original charter so that (1) the committee will go from six to seven members by striking the treasurer as ex-officio and giving the treasurer full membership status, and (2) to change the name of the committee to "Historical Preservation Committee." Motion carried. Moved By Tom Trulen, seconded by Judy Schwartz to replenish the Historical Preservation Committee's funds by \$3,750. Discussion. Motion amended and seconded to fund \$6,750, for a total budget of \$10,000. Discussion. Motion carried.

Pres. Olson reported on the amount of interest earned by RWCS in 1997. It was \$6656.00. He explained the BOD recommendation for the money. Moved by Jerry Schleich, seconded by Vi Malmquist to donate \$1,656 unrestricted funds to the Goodhue County Historical Society, and the remaining \$5,000 designated to an oral history project of RWCS potteries. Discussion. Motion carried.

New Business Jill Holmes request-

ed the by-laws be reviewed so elections of officers and standing committee chairs is staggered. This would eliminate all the officers or all the committee chairs from leaving all at once. Currently, RWCS rotates between officers and chairs every two years, but all could exit at once! By-laws revision will be reviewed.

John Key recognized the outgoing BOD members, President Olson, Vice-President Cronmeyer, Secretary Busse-Nelson, East Representative Osterholz, and former Convention chairs David and Diane Hallstrom

Elections: There were no volunteers or nominations for the Convention chair. President Olson declared the nominations for West Representative be closed. Candidates were Sharon Cox of Iowa and Wally Armstrong of Washington. Wally Armstrong was elected. Nominations for East Representative were closed. Candidates were Mike Zaeske of Michigan and Jerry Erdmann of Wisconsin. Jerry Erdmann was elected. Nominations for Historian were closed. Candidates were Pete May of Minnesota and Steve Brown of Illinois. Steve Brown was elected. Nominations for Secretary were closed. Candidates were Craig Rang of Montana and Sue Jones-Tagliapietra of Wisconsin. Sue Jones-Tagliapietra was elected. Moved by Rich Cronmeyer, seconded by Steve Brown to cast a unanimous ballot for Jerry Flicek as Treasurer. Motion carried. Nomination were closed for Vice-President. Candidates were Wendy Callicot and Byron Bush. Wendy Callicot was elected. Moved by Mike Zaeske, seconded by Wally Armstrong to cast a unanimous ballot for Corrinne Reed as President. Motion carried.

Adjourned at 5:50 pm.
