- lost, stolen, or damaged articles.
- RWCS will provide 24-hour security for the loan period either by Contracted Security during display hours or locking the room when the Display Room is not in operation.
- There are 9 total possible awards: Best of Show and People's Choice in each of the standard categories (Art Pottery, Dinnerware, Memorabilia, Stoneware), and one for People's Choice Dennis Yaeggi Rare Item Award. The winning display member will receive a special commemorative. If a display wins both Best of Show and People's Choice, only one special commemorative is awarded.

Non- Competitive Categories

- Non-Competitive category displays are not eligible to win a special commemorative.
- Any chapter setting up a display receives one regular commemorative for participation.
- These displays by Chapters or by the RWCS Commemorative Committee may include signage identifying the Displayer, but no 'For Sale' or 'Looking For" signs are allowed.

Rules of Participation

- All displays must have an accurate inventory of all items on display at the time of set up. A copy of this will be supplied to the Display Committee. The inventory list will be checked and signed by a Display Committee member upon completion of set up and before removal of any display.
- Each item on display must be labeled with a sticker to include the Member/owner's name, address, and membership number. Any item(s) that cannot have a sticker, such as paper items, make a detailed entry on the inventory.
- The Display cannot include any signage with member name(s) or numbers, 'For Sale' or 'Looking For' signs, etc.
- No one is allowed behind the ropes to a display from Thursday, 1:00 p.m. until Saturday, 12:00 p.m.
- Signs should be easily read from a distance of at least four feet.
- Display set up time is Thursday, July 7, 2016 from 8:00 a.m. 1:00 p.m. and Removal time is Saturday, July 9, 2016 from 12:00 p.m. – 3:00 p.m. Wednesday, July 6, 2016 early set-up will be allowed from 12-3:00 pm BY APPOINTMENT ONLY.
- Insurance is the responsibility of the Member as lender/owner to the RWCS Annual Convention Display Room.

Votina/Judaina

- Regular Displays will be judged for Best-of-Show and People's Choice Awards. Rare Items will be judged for the Dennis Yaeggi Rare Item Award by people's choice.
- Winners of these awards will be announced on Friday at the Annual Business Meeting and receive a special commemorative, as detailed above.
- VOTING: General RWCS membership in attendance at the Annual Convention votes for People's Choice. Voting will begin Thursday, at 3:00 pm., and end Friday, at 3:00 p.m. A team of judges appointed by the Display Committee will vote for Bestof-Show using the following criteria: a) quality of pieces (for as common or rare as they may be), b) representation and relation of types of pieces, c) related props, etc. that enhance display, and d) educational value/materials.
