Trial Membership Offer Local Chapter Involvement

Motion by Steve Brown seconded by Bob Morawski to allocate \$5000 that was earmarked for the contingency fund for 2010 be given to the Membership Committee. Motion carried.

#### **Foundation Update**

The RWCS Foundation representatives met with the RWCS Board to begin a mutual exchange of information between the two Boards and to facilitate improved communication.

Foundation President Dave Kuffel shared some comments & opinions from people that have visited the RWCS Foundation Museum.

The Foundation is in the process of procuring the Sears building. The building is 8900 Square feet, which is about 3 times larger than the current space.

Larry Peterson gave an update on the procurement of the Sears Building and that the attorney's are working on getting the terms correct. He also thanked the RWCS for the contributions that the Society has given to the Foundation.

Dave discussed where the money and support would possibly come from for the museum. Red Wing Collectors Society, City of Red Wing, Grants, Chamber of Commerce.

Jerry Erdmann suggested that the information on where visitors are coming from be published in the Newsletter.

Mark Collins discussed the mission statements of the Foundation and the RWCS. The feeling is that the mission statements are too close to the same.

Mark also brought up the topic that most Foundation Boards, are made up of outgoing members from the current Board of Directors from the National.

Bruce Cameron gave a recommendation that updates should be done on the Mission Statements for both the RWCS and the Foundation.

Motion by Mark Collins seconded by Jolene to go out of Executive Session at 1:48 AM. Motion carried.

Motion by Steve Brown seconded Bob Morawski to approve a 0% increase in base salary and increase with a ceiling of \$500 per month the Health Savings Account. Motion carried.

Motion by Mark Collins seconded by Paulette Floyd to amend the 2010 budget to reflect the increase in Executive Directors Compensation Package and amend the appropriate documents. Motion carried.
