Motion by Mike Robinson seconded by Bonnie Myers to approve the minutes of the July 8, 2005 RWCS Annual Business Meeting. Motion carried.

Treasurer's Report was given by Mark Collins. Mr. Collins presented the Statement of Revenue and Expenditures for the year ending December 31, 2005. The total revenues were \$548,405.44 and expenditures were \$527,726.57 for net revenue of \$20,678.87 The treasurer's report is published in the newsletter on an annual basis.

- Auction report was given by Jeff Floyd. Total sales realized from the Auction were \$144,360.
 - New this year was the use of Credit Cards. The amount charged by credit card was over \$20,000.

- Commemorative Report was given by John Tremble. The 2006 Commemorative is a Round Up Teapot. There were a total of 4900 pieces. The last production piece is being displayed in the RWCS Business Office and later in the RWCS Foundation Museum.

- Education report was given by Terry Speedy. Terry thanked everyone that gave a seminar and all of the volunteers. There were approximately 900 members who attended seminars. There were 4 sessions and 26 classrooms used for the seminars. The Keynote Speaker was the Minnesota Historical Society.
- Kids View report given by Wendy & Sue. "Hats off to Collecting" was the theme. 98 children attended the Kids View Seminars.
 - The Auction was again a success along with the painting of plates and the making of stoneware jugs.
 - The kids were also given a tour of the Display room.
 - The Kids View plate was purchased for \$225. A big thank you was given to the person who purchased the plate.
 - Thanks were given to Mike Robinson, Beth Zamzow and Red Wing Stoneware for the little jugs this year.
- Business Manager Stacy Wegner .
 - The Welcome Window Winner was announced. A 1-year complementary membership and a commemorative was presented to Tom Withers from Josephsons Clothing Store in Red Wing.
 - Thanks were given to Diane & Dave Hallstrom, along with all the Managers, Lori Anderson, Wally Armstrong and all the Volunteers.

- **Membership report given by Lori Anderson.**
 - 2050 members attended the 2006 RWCS Convention from 29 states.
 - Active membership is 5,016, which includes Primary, Associate and complimentary.
 - New members from January 1, 2006 until convention are 162 with 10-15 new members joining during convention.
- **Representatives at Large Reports were given by Jerry Erdmann & Wally Armstrong.**
- **Wally Armstrong said his goodbye's .**
- **Jerry Erdmann – All Chapters are doing well. Jerry Erdmann had Kay Salisbury from the Trail's West Chapter talk about a Quilt that they would like to have made with a square from all Chapter to possibly be raffled. This is still in the planning stages.**
- **The Trail's West Chapter donated \$500 to the Foundation for the Hutchson Collection. They also challenged all other chapters to do the same.**

Historian Report was given by Steve Brown.

- **Steve gave an overall assessment of the RWCS which continues to be the most educated collectors in the marketplace today. The relationship between the RWCS and the Foundation and the City of Red Wing are strong and the planning of next years celebration continues.**

Foundation Report was given by Ron Linde – Foundation President.

- **Ron thanked everyone that put up displays in the Museum. Deanna & Jay Jurgens and many individuals from the Iowa Chapter.**
- **Ron talked about the development of the Pottery Park. There is approximately \$30,000 that will be needed to complete this project. The City of Red Wing will donate \$15,000 and the RWCS Foundation has been asked to raise the remaining \$15,000.**
